- Documents must have a 3 inch blank margin at top of first page and 1/2 inch blank margin on remaining sides of first page and on all sides and top of subsequent pages.
- Letter and Legal sized documents accepted.
- ABSTRACT only documents can be filed electronically
- 300 DPI on all Images
- Hours of Operation: M-F, 8:00 AM to 3:00 PM (Cut Off Time)
- Conveyance Documents are not accepted electronically by the county at this time
