

Document Bulletin for Goodhue County, MN

Goodhue County, MN is now electronically recording documents through CSC.

Available documents and required fields are listed in the attached table.

If this county has not been added to your drop down list and/or you would like to e-Record in this county, please contact your CSC representative.

General Requirements for all documents:

- A margin of at least 1/2" inch is required around the entire document and a blank 3X3" at the top right of first page.
- Letter and Legal sized documents accepted.
- County will process e-recordings Monday-Friday between the hours of 8:00 am and 4:30 pm.
- Images must be submitted at 300dpi.
- Abstract and Torrens documents will be accepted electronically
- NOTE: Deeds are not accepted at this time and Mortgage documents requiring MRT Tax are not accepted at this time. Any available mortgage documents (ie. Assignment of Mortgage, Modification of Mortgage, etc with an MRT Tax will be rejected by the county).
