



## Document Bulletin for Burnett County, WI

Burnett County, WI is now electronically recording documents through CSC.

Available documents and required fields are listed in the attached table.

If this county has not been added to your drop down list and/or you would like to e-Record in this county, please contact your CSC representative.

### General Requirements for all documents:

- A margin of at least 1/2" inch is required around the entire document and a blank 3"X3" square at the top right hand corner of the document.
- Letter and Legal sized documents accepted.
- County will process e-recordings Monday-Friday between the hours of 9:30 am and 3:30 pm CST.
- Images can be submitted at 200 or 300dpi.
- Deeds require a Transfer Tax attachment and incur a \$.30 tax per \$100.00 transferred. Any amount over a \$100 point must be rounded up to the next \$100. (ex. \$202.34 will need tax calculated on \$300.)
