- 3X3 inch margin at the top right hand corner of first page and 1-inch margin on the top of each page.
- Legal and Letter sized documents accepted.
- 200 DPI accepted for documents
- Recording Hours: M-F, 8:00 AM to 5:00 PM EST
- Derivation Clause required except on Quit Claim Deeds.
- Tax District, Map, Preparation Clause, and Parcel # required on all Deeds and Plats.
