- Margins are 1/2" Top Margin with 3 1/4" x 2 1/4" space on top right of first page for recordation stamp. 1/2" side and bottom margin and on subsequent pages.
- Legal and Letter Sized Documents Accepted
- Recording Hours: M-F, 8:00 AM to 4:00 PM
- 300 DPI on all images required.
- Note: L3 Documents are not currently accepted at the county
