**General Requirements for all documents:**

- A top margin of at least ½” inch on all pages and a 1/4” inch margin on the bottom and sides. The upper right hand corner of the document must be completely blank (at least 3” by 3”) for our official recording stamp.
- Letter and Legal sized documents accepted.
- 300 DPI on all Images.
- Recording Hours: M-F, 8:00 AM to 3:30 PM
