General Requirements for all documents:

- 3" margin required on top of first page, all other margins to be 1/2" on all pages
- Letter and Legal sized documents accepted
- At least 8-point font required
- 300 DPI accepted for documents
- No Torrens at this time (only 30 or 40 parcels in county)
- Recording hours are M-F, 8:30 AM to 4:30 PM (Cut-off, can be submitted any time)
