**General Requirements for all documents:**

- A margin of at least 2” inch is required at the top of the first page with 1” on the sides and bottom and at the top of subsequent pages.
- Letter or Legal sized documents accepted.
- Images must be submitted at 300dpi.
- Recording Hours: M-F, 8:30 to 4:30 PM (County will accept docs at any time).
