General Requirements for all documents:

- All margins on all pages to be 3/4" except for top margin on first page, which must be 3".
- Minimum 8 pt font required
- Only Letter sized documents accepted
- 300 DPI accepted for documents.
- Recordings must be submitted before 3:30 PM for same-day recording (not guaranteed, but likely. Can be submitted any time)
