Fayette County, IN is now electronically recording documents through CSC.

General Requirements for all documents:

- On the first and last pages, provide a top and bottom margin of at least 2 inches. Side margins can be at least 1/2 an inch. Subsequent pages can have margins that are a minimum of 1/2 an inch.
- Letter and Legal Sized Documents Accepted
- Recording Hours: M-F, 8:00 AM to 4:00 PM
- 300 DPI on all images required.
- Deed document types are not accepted electronically at this time.
